CREDIT RELATED SERVICES AND GENERAL COSTS

- A. Proposed financial BUDGETING ADVICE is included in every Full Contract at no additional charge to Buyer. (Advice is instructional and intended to assist with credit improvement over time.)
- B. \$300.00 for each Budget outside of the original six, requested by Buyer in addition to, or as a re-figuring upon the unconstrained purchasing or financial actions by the Buyer which during contract term might negate an original Budget for a particular period.
- C. \$500.00 BUDGETING as a separate service as outlined above, with no credit repair or negotiation. (One time)
- D. \$75.00 for each inquiry removed from each credit bureau. (Each bureau)
- E. \$100.00 for each derogatory account listing removed from each credit bureau. (Each bureau)
- F. \$700.00 Lawsuit or Judgment Negotiation, plus 10% cost for saved amounts out of any Settlement. (see, item "H", following)
- G. 10% (to a maximum not to exceed \$3,000.00) of amounts saved out of each Settlement, including multiple bureau listings of any single item across all bureaus, following negotiation and acceptance by Creditors. (Including Settlements to be paid in payments. Buyer remains solely responsible for the original debt.)
(Example: Debt of \$10,000.00 settled at \$5,000.00. (10% X 5,000.00) Our fee would be \$500.00. Our fee is due in full as one payment upon the Creditor acceptance of the Settlement.)
- H. \$300.00 for each full balance repayment plan negotiated with and accepted by Creditors. (D.R.I. is not responsible for any negotiated payment plan default by Buyer following plan initiation. Buyer remains solely responsible for the original debt.)
- I. \$300.00 for each FICO score increase of 100 points or more on each credit bureau. (Each bureau)
- J. 50% of any monetary award recovered from any legal action which D.R.I. might recommend filing against any uncooperative or unresponsive Creditor, and filed by Buyer against the offending Creditor during the process of negotiation.
- K. \$50.00 for "IN-HOUSE" negotiation by telephone and email for purchase terms on a new lease or contract with potential lenders, leasing agents or credit grantors.

- L. **\$300.00** for negotiation and assistance to Buyer in obtaining a "Secured" credit card at going-rates, from a Banking institution.
- M. **\$100.00** for "ON-SITE" negotiation for purchase terms on a new lease or contract with potential lenders, leasing agents or credit grantors. (Most negotiations can be accomplished by telephone and email. Only rare circumstances would see this availability of on-site assistance as an option.)
- N. **\$300.00** for "ON-SITE" appearance with Buyer in Court on scheduled date for assistance and support during presentation of facts for claim filed against any Creditor as part of Credit Repair Contract.
- O. **\$1,000.00** for IRS Negotiation, IRS Payment Arrangements, or, IRS Offer In Compromise on IRS liability up to \$24,999.99.
\$3,000.00 on IRS liability of \$25,000.00 or more.
- P. **Low Income Rate** is available for total yearly income of approximately \$30,000.00, or less, with a total debt ratio encumbrance showing as greater than, or at least equal to all available funds. The D.R.I. counselor will discuss Buyers particular needs during the first meeting to determine the most beneficial and expedient plan for the Buyers Contract terms.
